The 2020 breeding season will start on February 3^{rd} , 2020, and complete on July 1^{st} , 2020, unless special arrangements are made in writing. Collection days are Monday, Wednesday, and Fridays only.

TO REQUEST SEMEN: Call Ashley Bona at (651) 357-5771 by 8:00 PM Central Time the day before needing shipment. Additional collection and shipping terms are as follows:

- 1. All orders must be called in. No email, social media, or text message orders will be accepted.
- 2. Cancellations must be made by 8:00 AM Central Time the day of the requested shipment, or you will be charged for the full shipment cost.
- 3. Shipments will default as FedEx Priority Overnight, unless otherwise specified.
- 4. Orders will be filled on a first come, first served basis. A signed contract does not guarantee shipment, and the stallion owner/agents are not responsible for costs arising from a missed cycle.
- 5. It is our promise that we will send a quality sample, in adequate packaging. However, Top Line Breeding, LLC or its agents are not responsible for any costs arising from shipments that are lost, damaged, delayed in transit, or for the condition of cooled shipped semen upon delivery, as we have no control over how the package is handled once it has left our possession.
- 6. Semen will not be shipped without a current credit card with expiration date, CVV code, and billing zip code on file with Ashley Bona.
- 7. Semen is to be used only for the mare specified on this contract. If any additional mares are bred using the semen, the mare owner will be billed for an additional stud fee.

The mare listed above shall be eligible for a re-breed contract under the following conditions:

- 1. If the mare dies, or is otherwise deemed unfit to breed during the breeding season, a substitute mare, approved by Top Line Breeding LLC, may be bred without any additional breeding fee.
- 2. Live Foal Guarantee: A live foal is defined as one that stands and nurses without assistance. If foal is born dead, the mare owner agrees to provide the stallion owner with a licensed veterinarian's letter confirming the occurrence within 7 days. If the mare aborts, or fails to conceive, she may return during the current breeding season for no additional cost other than shipping/collection fees. If it becomes too late to re-breed the mare within the current season, she may be bred the following year, provided a re-breed contract is completed, an additional \$400 re-breed fee is paid, and all shipping/collection fees are paid.
 - a. In the event of a late-term abortion, or still born foal, the mare owner must provide the stallion owner with proof of genetic testing stating the mare is N/N for glycogen branching enzyme deficiency (GBED). If the mare is confirmed a genetic carrier, no rebreed contract will be granted, the contract will be considered void, and the stallion owner and agents will not be responsible for any refunds.
- 3. Color Guarantee: If the foal is born without the qualifying markings or color genetics/traits to be registered in the American Paint Horse Association in the regular registry, the mare may be rebred, provided a re-breed fee of \$300 and all relevant collection and shipping charges are paid.
- 4. If the Mare Owner fails to return the mare for breeding the following year, then any and all fees paid shall be forfeited, the right to rebreed is cancelled and the Stallion Owner is released from all further obligation of the contract, unless otherwise agreed to in writing and signed by all parties.

The Mare Owner understands and agrees to:

- 1. The mare must be checked in foal by a licensed veterinarian within 18 days of ovulation if an ultrasound is available, within 34 days if not. The mare must be reported in foal or open to Ashley Bona no later than 40 days after shipment is sent. Failure to report pregnancy by August 1st, 2020 will result in a \$50 late fee to add the mare to the stallion's breeding report.
- 2. The mare and foal's health and mortality are the full responsibility of the Mare Owner before, during, and after this breeding. The Stallion Owner or its agents are not liable for death, sickness, injury, accident, or damage occurring to the mare or foal for any reason.
- 3. Embryo Transfers: The Mare Owner must notify the Stallion Owner if the mare will be used for embryo transfer. In the case of multiple embryos from a single flush, the Mare Owner will be responsible for an additional stud fee, which must be paid at the time of birth if more than one living foal is produced in order to receive additional breeder's certificate(s).
- Lazy Luvah's genetic testing that has been done to date includes:
 HYPP N/N, PSSM1 N/N, MH N/N, GBED N/G, HERDA N/N, OLWS N/N, Splash White-1 N/SW-1
- 5. In the event that the stallion dies, or becomes unfit for service for any reason, this agreement will immediately terminate. Stallion Owner and its agents shall have no obligations to Mare Owner, except for notification of its occurrence.

I, as the Mare Owner, hereby agree to the aforementioned terms and conditions of this contract, and understand they are deemed final upon completion and signature of this contract. Any deviations must be specified in writing, and signed by Top Line Breeding LLC or Ashley Bona.
